In the case of Villa or Coach Home units, a separate sales application is required as well as a non-refundable processing fee made payable to the appropriate association. See page 2.
- 5. The completed Master Association application must be submitted at least 30 days prior to the expected closing date.
- 6. Please attach a copy of the driver's license of all parties listed on the application.
- 7. No commercial vehicles, trucks, boats, trailers, motor homes, campers, recreational vehicles, motorcycles, etc. are permitted to be parked on the premises overnight, unless housed in a garage.
- 8. Units are not permitted to be leased or rented for a period of 3 years from date of purchase.
- 9. Purchaser must notify the Association office with the exact date of their closing.
- 10. We prefer all moving of furniture in or out of a home occur on Monday through Saturday between the hours of 8:00 A.M. and 6:00 P.M.

June 8, 2021

On May 18, 2021, the Board of Directors passed a Capital Contribution change to be come effective July 1, 2021. This Capital Contribution of \$1,000.00 per Single Family Home, Condominium or Villa, will not alter any "pending sales or pending with contingency sales" received by the Marsh Landing Community Office before July 1, 2021.

The Marsh Landing Board at their June 8, 2021 meeting, passed a Special Assessment for all condominiums, villas, and single family homes in the community, for \$300.00, and to become payable August 1, 2021.
