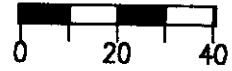
COMMENCE AT THE NORTHEAST CORNER OF SAID TRACT "C"; THENCE S.06°41'21"E., ALONG THE EASTERLY BOUNDARY OF SAID TRACT "C" A DISTANCE OF 541.76 FEET; THENCE S.08°36'00"W., A DISTANCE OF 631.85 FEET TO THE POINT OF BEGINNING; THENCE S.42°11'15"E., A DISTANCE OF 78.28 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT, HAVING: A RADIUS OF 90.00 FEET, A CENTRAL ANGLE OF 26°59'09", A CHORD BEARING OF S.28°41'41"E. AND A CHORD LENGTH OF 42.00 FEET; THENCE ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 42.39 FEET TO THE POINT OF REVERSE CURVATURE OF A CURVE TO THE LEFT, HAVING: A RADIUS OF 58.00 FEET, A CENTRAL ANGLE OF 137°03'38", A CHORD BEARING OF S.83°43'55"E. AND A CHORD LENGTH OF 107.95 FEET; THENCE ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 138.75 FEET TO A POINT ON A CURVE TO THE RIGHT, HAVING: A RADIUS OF 10871.16 FEET, A CENTRAL ANGLE OF 00°37'58", A CHORD BEARING OF S.06°00'30"E. AND A CHORD LENGTH OF 120.06 FEET; THENCE ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 120.06 FEET TO THE END OF SAID CURVE; THENCE S.88°37'08"W., A DISTANCE OF 87.79 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT, HAVING: A RADIUS OF 80.00 FEET, A CENTRAL ANGLE OF 47°45'04", A CHORD BEARING OF N.67°30'20"W. 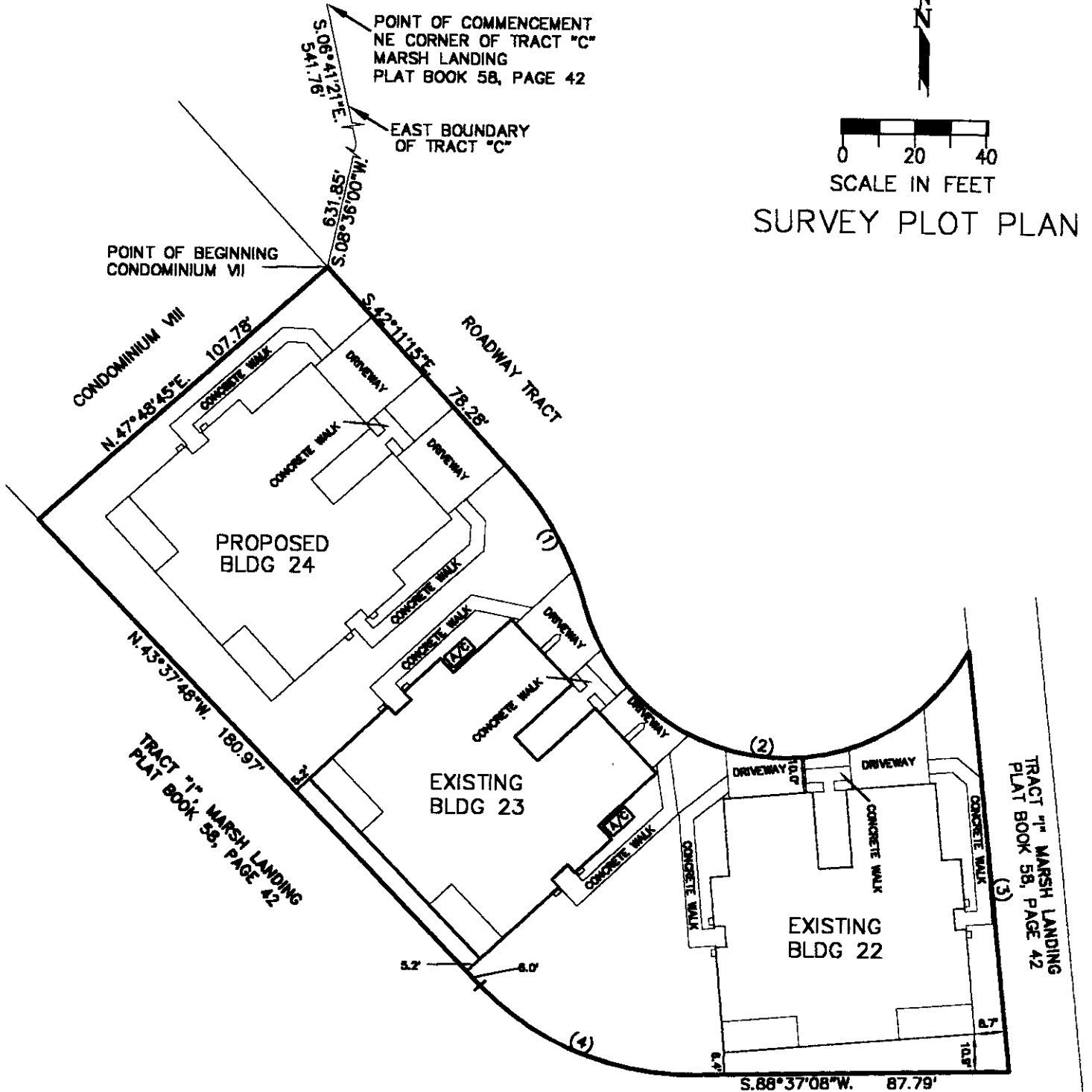

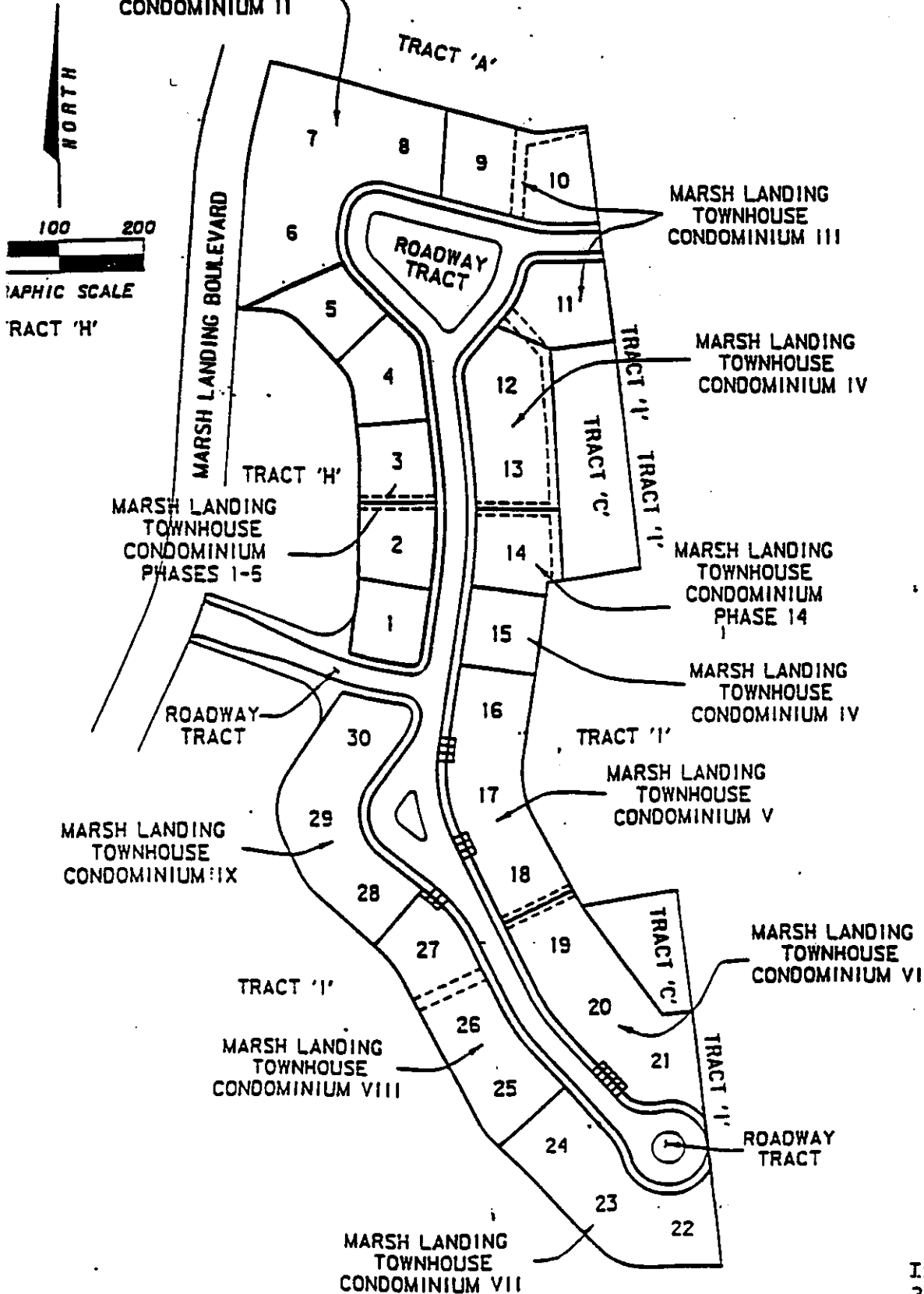
