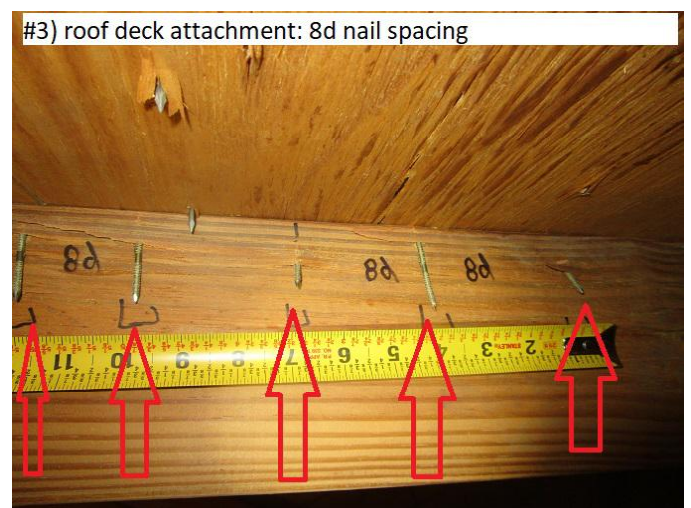

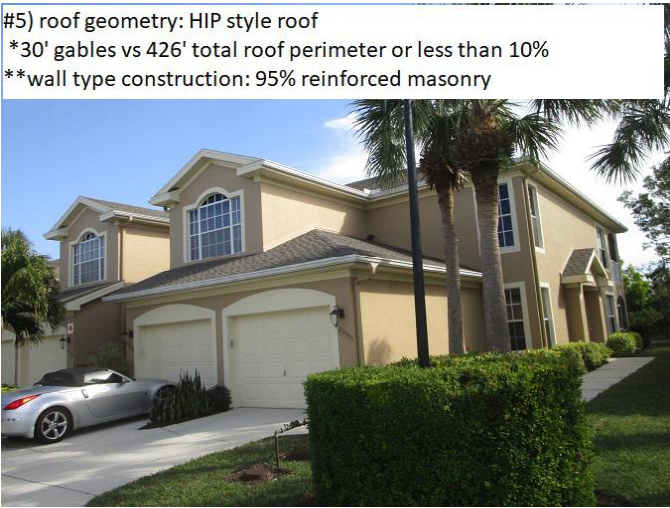


#2) roof covering: 2016 dimensional asphalt shingle HIP style roof

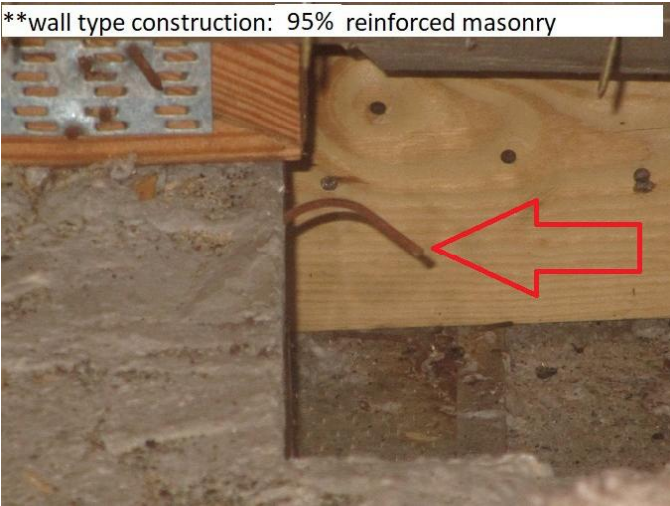
#5) roof geometry: HIP style roof

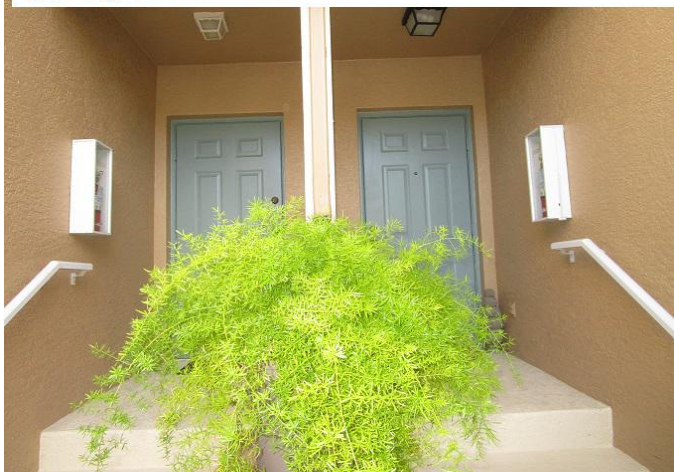
